PART II SECTION B TECHNICAL SPECIFICATIONS

The project involves the development and integration of additional features in the Online Database Management System (web portal) of 'Environmental Awareness and Education' scheme of DoECC.The Online Database Management System includes four micro portals - Bhoomithrasena Clubs, Paaristhithikam, Training Programs/Workshops, Paristhithimithram Awards and Mobile Application (BMC Club). The web portal (https://schemes.envt.kerala.gov.in) is currently hosted in the State Data Centre after conducting its security auditing.

The source code and installation guide of the web portal will be provided. The selected bidder shall provide development and integration of the additional features for the micro portals as given below.

Service Provider Responsibilities

The service provider will be responsible for the development, testing, and implementation of the following features:

1. Bhoomithrasena Clubs Micro Portal

1.1 Bhoomithrasena Clubs Club Finance(Admin End):

• There should be three separate tabs - one for New Clubs, second one for recurring grants for existing clubs as exists in the portal now, and third one for Best Bhoomithrasena Club Awards

1.2 Faculty-in-Charges Certificate Provision:

- There should be provision to give certificates to Faculty-in-Charges (process similar to student certificate approval). At the user end, from the FIC login, there should be facility to request for FIC certificate, then forward to Principal and from Principal Login the certificate should be submitted to DoECC. At the admin end, provision should be there to approve the certificate.
- As part of this, a repository of FIC's details and duration of charge should be there at the admin end.

1.3 Additional Program Categories (User &Admin End):

• Three more 'Program Category' should be included in addition to the existing 17 categories. They are 1) 'Participation in Environmentally Relevant Events Conducted by Other Agencies/Institutions,' 2) 'Programs for Engaging Bhoomithrasena Alumni' and 3) Energy Conservation. Additionally, all the 20 Program Categories should be fetched in the BMC Evaluation Reports.

1.4 Quantification of Activities(User & Admin End):

- For the 'Waste Management' Category, when a program is being 'Mark as Completed,' there should be additional data entry boxes with the main title 'Quantity of Waste Managed (in kilograms)' just below the 'Program Note' box. Different Categories that should be given under the main title are Plastic, Biodegradable Waste, E-waste and Hazardous Waste.
- For the 'Water Conservation' Category, when a program is being 'Mark as Completed,' there should be an additional data entry box with the title 'Quantity of Water Conserved (in litres)' just below the 'Program Note' box.
- For the 'Energy Conservation' Category, when a program is being 'Mark as Completed,' there should be an additional data entry box with the title 'Quantity of Energy Conserved (in Kilo Watt Hour)' just below the 'Program Note' box.

1.5 Dashboards(Admin End):

- Pendency of 'BMC Evaluation Report' should be displayed in the Admin Dashboards of AEO, EO and EPM.
- Pendency of 'Award Report' should be displayed in the Admin Dashboards of PC, AEO, EO and EPM.

1.6 'BMC Evaluation Report' Page Enhancements(Admin End):

• Additionally, one more option titled 'Shortlist for Awards' should be there along with 'Regenerate,' 'Forward,' and 'Export.'

1.7. Award Management Provision (Admin End):

• At the admin end: BMC --> just below 'BMC Evaluation Report' --> there should a menu titled 'Award Management.'Under the menu, there should be a provision for Award intimation to the selected clubs annually.For which, the list of clubs sorted by annual year, zone wise, category (College/HSS) wise should be listed and from which EPM could select the awarded club and there should be a button named 'Send Award Intimation.'By clicking on the button, an auto generated message should be received to the selected clubs.

1.8. Award Management Provision (User & Admin End):

- In the user end, under 'Award Management' tab, there should be a provision to add program plan, upload award report, expenditure statement and utilization certificate in KFC Form and submit to DoECC as in the case of the BMC Annual Report Section.
- And at the admin end under the 'Award Management' menu, these documents should be able to view and process through the hierarchical level as in the BMC annual reports.

1.9. Alumni Registration (User End):

- Alumni who are given Bhoomithrasena Club Certificates through portal possess a unique student ID, so these alumni shall be able to login with their student ID as username and password.
- This username and password should be sent to the student's email ID along with the Bhoomithrasena certificate.
- Suggestion: Password can be a combination of first four letters of their name and date of birth in day, month and year format. Eg: GEOR12012024.

1.10. Alumni Registration - Password Change (User End):

• Alumni should have a provision to change their passwords by clicking on 'Forgot Password.'At present, there is no such provision.

1.11. Alumni Feedback Notification (User End):

• HOI/FIC Login --> Alumni Feedback --> When an Alumni sends feedback, a notification should be there at the top of the FIC and HOI accounts, so that they will be notified and could read the feedback or reply.

1.12. Announcements (Admin&User End):

All the announcements made in the portal should be also received at the email of

Principal and Faculty-in-Charge.

- 1.13. There should be a provision to automatically remind the FICs about the timely enrolment of students in the portal in July and November of each academic year (at the user end).
- 1.14. Principal/HOI Login --> Annual Report Submission --> There should be only one PREVIEW tab with three buttons PREVIEW PDF, SEND TO FIC FOR RECTIFICATION, and APPROVE AND SUBMIT TO DOECC. No need of Draft, Generate ES, Generate UC tabs(at the user end).

Note: The provision to return the 'Annual Report' from Principal/HOI to FIC through SEND TO FIC FOR RECTIFICATION button is necessary if any corrections/editing are needed before final submission.

1.15. Student Enrolment (User End):

Bulk student enrolment should be made possible. For example, FICs can upload the students' details in an excel sheet or so in the portal, then the individual details should be fetched in the system separately.

1.16. BMC --> Club Management --> Registered Clubs --> Action button (on the right hand side of all listed clubs) --> At present, there are only two options - VIEW & CHANGE BMC CODE. There should be also one more action titled 'REMOVE CLUB' (at the admin end)

Paristhithimithram Awards (Admin End):

- The links (youtube video link and google drive link) given in both 'the achievements in the award year' and 'life time achievements' in the application by the applicant is not separately visible to the admin in the portal. All the inputs uploaded for the award year and 'life time achievements' such as newspaper reports, publications, photos, videos and google drive links should be shown separately in the admin side of the web portal.
- At the admin side, a year wise filtering of applications received should made possible.

3. For all micro portals (Admin & User End):

• Announcement Section should be made available for all the four micro portals & program specific announcements made in the section should be displayed in the home page of each micro portal. For example, notification for the Paristhithimithram Awards should be displayed in the home page of Paristhithimithram Awards micro portal.
